DOG ELIGIBLE TO ENTER

Please refer to the AKC website for eligibility standards for each test. In order to gain the title on successful qualifications, dogs must be registered in American Kennel Club or AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds is required.

Females in season, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds. Aggressive dogs, including but not limited to dogs that have been disqualified and not reinstated by the AKC, as well as any dog that has been deemed aggressive, dangerous and/or vicious by any governmental entity are not eligible for entry.

By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Cleveland All-Breed Training Club, Inc. and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Cleveland All-Breed Training Club, Inc. reserves the right to decline entries for cause and may remove any dog due to aggression. No one shall have any recourse or claim against the Cleveland All-Breed Training Club, Inc. or any official thereof. **All dogs must be on leash** at all times.

REFUNDS

No entry fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

AKC TEMPERAMENT TEST INFORMATION

The **AKC Temperament Test (ATT)** was developed to bring focus and provide a meaningful evaluation to assess the temperament of our canine companions.

The ATT tests how a dog reacts to a variety of stimuli. Desirable traits are that the dog will be emotionally stable, inquisitive, cooperative, appropriately social for its breed, biddable and demonstrates the ability to recover from a startling situation in a reasonable amount of time.

Undesirable traits are fear, shyness, lack of cooperation and an inability to recover from unfamiliar or unexpected situations. Examples of undesirable behaviors include being afraid of friendly strangers or unfamiliar stimuli, obsessive barking, and aggression.

In the ATT, dogs are tested in 6 categories of stimuli that include:

- Social
- Auditory
- Visual
- Tactile
- Proprioceptive (motion)
- Unexpected stimulus

*Each dog needs **two** qualifying scores under two different judges in order to achieve an ATT title.*

ATT COMPONENTS

SOCIAL

- Greets handler, pets dog
- Evaluator approaches, brief exam
- Approach standing person, pets dog
- Person approaches w/ item, pets dog

AUDITORY

- Shake large plastic bottle w/coins
- Vacuum cleaner (hand held)
- Loud whistle
- Bike horn (bulb)

VISUAL

- Umbrella opened
- Roller bag, wagon, crate dolly, cooler
- Streamers on stick
- Shake hand towel

TACTILE

- Walks on wire grate
- Plastic tarp
- Plastic lattice over memory foam.
- Pegboard over air mattress

PROPRIOCEPTIVE (motion, position)

- Cavaletti
- Intersecting hoops (8)
- Low teeter
- Up and over low platform

UNEXPECTED STIMULUS

- Approach, carries box & objects
- Approach, drops chair
- Uses walker, crutches, wheelchair
- Approach briskly - unusual clothing

CLEVELAND ALL-BREED TRAINING CLUB EVENT RULES

- Plastic tarp or mat must be placed under crates & ex-pens.
- NO smoking inside the building.
- NO bitches in season permitted.
- No flash photography or light for video cameras permitted.
- Dogs are not allowed to relieve themselves on any building, on the grass across the parking lot, or on the neighboring property.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the event grounds.

DIRECTIONS TO THE EVENT SITE

From the West (via Ohio Turnpike): Take the Ohio Turnpike and get off at the I-480 exit. Take I-480 East to Rt. 176 North.

From Rt. 176 North: The next exit is Spring Rd/Hinckley Parkway. Turn right onto Spring Rd/Hinckley.

From Spring Rd./Hinckley Parkway: Shortly after turning onto Spring Rd/Hinckley Parkway, they separate into 2 roads. Stay left and turn left onto Spring Rd. (Hinckley Pkwy continues straight ahead). Spring Rd dead-ends at Van Epps (at the stop sign). Make a very slight right turn onto Van Epps. The next street is Hayes Dr. Turn left onto Hayes Drive. 210 Hayes Drive is the 2nd building on your left.

From the East (via Ohio Turnpike): Get off at the I-77 exit. Follow the signs to I-77. Take I-77 North to I-480 West. Immediately get off at the Rt. 176 North/Brook Park exit. Stay on Rt. 176 N and then follow above directions for "From Rt. 176 North."

From the South (and hotels): Take I-77 North to I-480 West. Immediately get off at Route 176 North/Brookpark exit. Stay on Route 176 North and follow above directions for **“From Route 176 North.”**

From the North: Take I-77 South to I-480 West. Immediately get off at the Rt. 176 North/Brookpark exit. Stay on Rt. 176 N and then follow above directions for **“From Rt. 176 North”.**

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
