A/C & Cooling at CAPS

We have been working hard on the air conditioning situation and have found a solution that keeps the building cool for our dogs and ourselves. The best way to maintain cooling in such a large space is to minimize multiple doors opening and closing. **Friday through Sunday, ONLY the main entry will be available.** All other doors will be locked and only used for emergency exit.

MOVE UPS

Dogs may be moved to a higher class at the request of the owner as a result of qualifying for an agility title provided that the request is made in writing/email to the Trial Secretary. Move-up requests must be received no later than 6:00 pm Monday, August 11th
BEFORE moving up, please be sure you have the required 3 legs!

CONFLICTS

Per the AKC rep the inability to walk with your assigned height group does not constitute a conflict. You may walk with another height group prior to your run.

Please inform the gate steward during your walk thru (before your class starts) if you may have a potential conflict. **Put a "C" next to your name** and when your conflict is resolved you will run with your jump height. We cannot be responsible for a missed run if the gate steward has not been informed. Be creative. You can move up or down within your jump height or to a jump height before yours but not to a jump height after your class walks and runs. Do not ask the judges to run at the top of the jump height after yours. (Note: if multiple jump heights walk at the same time (i.e. all of Novice Standard) then moving between jump heights is fine with the judge's permission, moving to a jump height after yours is not.

MEASURING OF DOGS

AKC rules now require that if you do not have a temporary card or a permanent measurement on your dog, you must be measured. Please make sure that your confirmation shows whether or not you need to be measured. **You must be measured before you run.** Our judges are not VMOs but there will be one on the premises assisting, so you must be measured for the weekend.

NO THURSDAY SET UP

The building NOT be available to anyone on Thursday night.

EXHIBITOR SET UP

Friday set up will be available at 8:00 AM. If you would like to volunteer to help set up rings doors will open at 7:00 am. You can drop your tarp down and set up after the rings are ready.

Saturday and Sunday the building will open at 7:00 AM

It will close on Friday and Saturday nights as soon as everything is set up for the next day's trial.

If your dog is reactive (dogs that lunge, excessively bark or threaten dogs or people who walk by) they should be crated in a minimal traffic area. Please do not crate near the entrance or exits from the crating area or the doors to the outside. We appreciate your cooperation in this area.

FOOD

CAPS has completed their restaurant. They will have food available for breakfast and lunch, along with snacks & beverages ranging from \$4 to \$12. Luncheon specials will be offered for \$10-\$12. Workers will be able to use their tickets to pay for food. NO outside food is allowed in the building. There are also several restaurants within a short distance of the facility.

ACCOMMODATIONS

Check hotel policy/pet deposits for dogs, please pick up after your dogs and keep rooms and exercise areas clean! List of hotels is available on the CABTC website and on the premium, as well as information concerning RV camping and driving directions.

SHOW CONDITIONS

Indoors on soccer flooring in 100' by 100' rings. Contacts have a rubberized surface. The facility is air-conditioned. Please dress in layers for your own comfort.

LIMITATIONS

Only water is allowed on the turf – NO FOOD. The primary dog exercise area is IN FRONT of the building. Grass along sides and back of the building is also available. Pickup bags will be provided. Do not allow your dog to urinate on or in the building.

Housekeeping Rules - Protect this beautiful site!

Do not leave your dog unattended in any of the motel rooms. Please pick up after your dog(s) at the motel, in the park, and in the Fieldhouse – everywhere! **Failure to pick up both at the trial site and at the motel will mean expulsion from the show with no refund.** Use good doggie manners, do not allow your dog to urinate on or in the building, or at the motel.. You are responsible for protecting the turf. Please be sure to put a waterproof barrier, i.e. solid tarp instead of woven mat under your crates and x-pens. If your dog likes to dig, please use crates.

We know accidents happen, but pee and poop in the building are serious infractions. Take your dog outside, use belly bands if there is any doubt about your dog's behavior on the turf. Clean up is required with the solution (red spray bottle) available outside each ring and at the Trial Secretary station.

NO bitches in season permitted.

Crates and personal property can be left overnight. There will be no official security on site.

No flash photography or light for video cameras permitted.

REMEMBER ...In order to keep this site beautiful, we must keep it CLEAN at all times, this means both INSIDE and OUTSIDE

AED LOCATION & FIRST AID

An AED is located on the wall to the left when you walk into the fieldhouse.

First Aid is located on the equipment cart next to the trial score table in the center of the fieldhouse.

IMPORTANT REMINDER

Don't forget to check in with the gate steward before you walk your course or even earlier. If you don't check in and they pass your number, you could be marked absent.

RUNNING ORDER FORMAT & SCHEDULE & RUNNING ORDER

Height running order for all **ALL** classes each day will be **Small to Tall (4" up to 24")**
Classes will run in the order below unless the trial committee finds it necessary to make adjustments.

Walk thrus will begin 15 minutes prior to first dog on the line

STD walk thrus

Friday, Saturday, Sunday Master/Excellent 4-8 walk, run; 12" walk, run; 16" walk, run; 20 walk, run; 24/24C walk, run

Open and Novice will walk and run in their individual classes concurrently within each height.

JWW walk thrus

Friday, Saturday, Sunday Master/Excellent 4-8 walk, run; 12" walk, run; 16" walk, run; 20 walk, run; 24/24C walk, run.

Novice and Open will walk and run in their individual classes concurrently within each height.

Fast Walk Thrus

Friday, Saturday & Sunday FAST, ALL LEVELS TOGETHER,

Master/Excellent/Open Novice: 4/8/12/16 walk, run 20/ 24/24c walk, run

T2B Walk Thrus & Running: Could be adjusted as needed for the schedule

Premier JWW & STD

Friday & Saturday all heights walk together
