
The address of the test will be: Sunnybank Farm 12664 Sheldon Rd, Mantua, OH 44255

Make checks and money orders payable (in U.S. Funds) to the Cleveland All Breed Training Club and mail to the Test Secretary. You will be notified by phone or email within 24 hours of the draw. Please include either or both so that I can contact you. Entries will not be accepted without fees. Be sure to use an official AKC form or photocopy both sides. Don't forget to sign it. DRAWING OF ENTRIES - Entries shall be accepted up until the official closing date, even though the advertised limits have been reached. Please do not send an entry that requires a signature for acceptance. I am not always at home! Entries will be drawn by the Test Secretary on Thursday

September 25, 2025 at 7 pm at the home of the test secretary. The drawing shall be completely random among all entries received. Preference is given to those dogs who have not yet earned a TD (for the TD test) and not yet earned a TDX (for the TDX test). Due to the land & judge constraints if there are no TDs an additional TDX may be added. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth above, shall be assigned a position on the Alternate List corresponding to the order in which they were drawn. THERE WILL BE A WORKER DRAW TO TAKE PLACE BEFORE THE REGULAR DRAW AS PER AKC REGULATIONS & THE

BEFORE THE REGULAR DRAW AS PER AKC REGULATIONS & THE GUIDELINES LISTED ON OUR COUPON. THERE WILL BE ONE TRACK AVAILABLE AS A WORKER TRACK.

REFUNDS: Entries who pass an AKC approved test after the closing date of this test may withdraw from this test with full refund provided the test secretary is notified before the test date <u>and</u> there is an alternate to replace the entry. Call me as soon as you know! Those who decline to be placed on the alternate list shall have their entry fees returned or I can destroy your check. Any dog who makes the draw but cannot run may also have their fees returned <u>only</u> if an alternate <u>competes</u> in their place.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Show Committee. Exhibitors are governed by rules and regulations of the AKC and local ordinances as noted in your signed entry form. The Club is not responsible for any illnesses sustained. The well-being of the dogs, exhibitors and spectators is of paramount importance and, if it is necessary to cancel or stop the event before completion, no entry refund will be made. DRAWING FOR TRACKS: The Judges will assemble the participants in the test site parking lot for a drawing by lot for the running order of each participant. The times for the draw will be noted in the judging program. The order in which tracks are run and the number of each track shall be determined by the Tracking Judges. Judging will begin as soon as possible after the draw. ALTERNATE ENTRIES: If an accepted entry is absent on the day of the test, the Test Secretary will determine if any alternates are present. Alternates will draw for available tracks based on their place on the alternate list. If no alternates are present the judges will designate someone to draw for the absent dog, who may run the track if it arrives before the track is scheduled to be run. If it does not arrive by then it will be marked absent.

PRIZES - Each passing team shall receive a memento of their achievement. INCIDENTALS: The cover is medium grass and woods. According to AKC regulations, you must keep your dogs on leash at all times and, of course, please pick up your poop!
