**Friday** All levels 4-16 walk, 20/24/24c walk than all run No 5 minute break  
**Saturday** All heights walk, run together

**FAST - Exhibitors are responsible for announcing their particular level BEFORE they run.**

#### T2B Walk Thrus

**Friday and Saturday** All heights walk,run together.

## CONFLICTS

**Per the AKC rep the inability to walk with your assigned height group does not constitute a conflict. You may walk with another height group prior to your run.**

Please inform the gate steward during your walk thru (before your class starts) if you may have a potential conflict. **Put a "C" next to your name** and when your conflict is resolved you will run with your jump height. We cannot be responsible for a missed run if the gate steward has not been informed. Be creative. You can move up or down within your jump height or to a jump height before yours but not to a jump height after your class walks and runs. Do not ask the judges to run at the top of the jump height after yours. (Note: if multiple jump heights walk at the same time (i.e. all of Novice Standard) then moving between jump heights is fine with the judge's permission, moving to a jump height after yours is not.

## MEASURING OF DOGS

AKC rules now require that if you do not have a temporary card or a permanent measurement on your dog, you must be measured. Please make sure that your confirmation shows whether or not you need to be measured. **You must be measured before you run.** There is NO VMO at this show.

## NO THURSDAY SET UP

**The building NOT be available to anyone on Thursday night.**

## EXHIBITOR SET UP

**Friday set up will be available at 8:30 AM. If you would like to volunteer to help set up rings doors will open at 7:30 am. You can drop your tarp down and set up after the rings are ready.**

**Saturday and Sunday the building will open at 7:30 AM**

It will close on Friday and Saturday nights as soon as everything is set up for the next day's trial.

If your dog is reactive (dogs that lunge, excessively bark or threaten dogs or people who walk by) they should be crated in a minimal traffic area. Please do not crate near the entrance or exits from the crating area or the doors to the outside. We appreciate your cooperation in this area.

# Cleveland All-Breed Training Center Rules

**AED LOCATION & FIRST AID** – An AED is located at Suite A main entrance, (Door C) and straight ahead on the wall across from the adjacent office and agility floor entrance doors.

**First Aid Kits** are located at Suite A main entrance (Door C), Suite A obedience side to the right after passing through the kitchen, Suite B agility side above the counter in the pass through hall.

Don't park in front of loading doors/docks in any of the buildings in the entire complex in the parking lot or you will be towed.

There will be a designated unloading area. This area is on the west side of the building (not by the front doors). Please take no more than 5 minutes to unload and then move your car so others can unload.

There is no room for RV parking.

**Dogs are NOT allowed to relieve themselves on any building or on the grass/snow across the parking lot. There is a graveled potty area behind the building. This potty area will be strictly enforced!**

Anyone not cleaning up after their dogs ANYWHERE may be asked to leave by the show committee. No excuses.

NO bitches in season permitted.

There will be designated crating areas in Suite A. Please use a tarp/covering under your crates/Expens. Please do not crate in any other areas. We must at all times maintain aisles that open to the exit doors. We definitely don't want to make the Fire Marshall unhappy.

Crates and personal property can be left overnight. There will be no official security on site.

No flash photography or light for video cameras permitted.

There is limited viewing in the room where the dogs run. So all runs will be live-streamed and shown on a large screen in the crating room.

REMEMBER ...In order to keep this beautiful site and to keep our neighbors happy, we must keep the site CLEAN at all times, this means both INSIDE and OUTSIDE of the building.

## DIRECTIONS TO Cleveland All-Breed Training Center

Brooklyn Heights is 10 miles directly South of downtown Cleveland and 12 miles East of Cleveland's Hopkins International Airport.

From the West, take the Ohio Turnpike and get off at the I-480 exit. Take I-480 East to Rt 176 North.

From Rt 176 North. The very next exit is Spring Rd/Hinckley Parkway Turn right onto Spring Rd/Hinckley Parkway

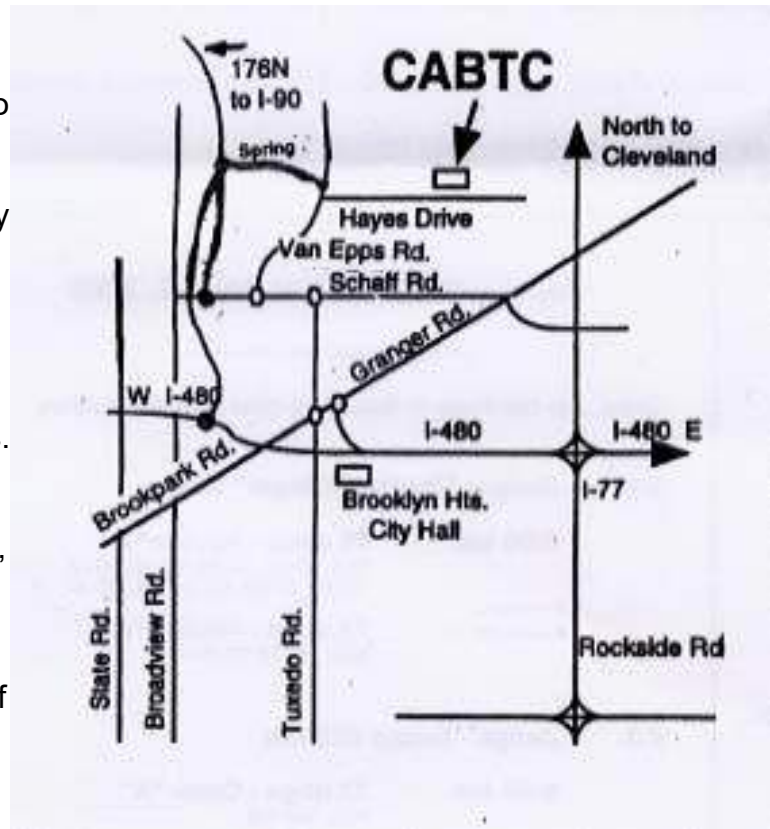
From Spring Rd/Hinckley Parkway. Shortly after turning onto Spring Rd/Hinckley Parkway, they separate into 2 roads. Stay left and turn left onto Spring Rd (Hinckley Pkwy continues straight ahead). Spring Rd dead-ends at Van Epps (at the stop sign). Make a very slight right turn onto Van Epps. The next street is Hayes Drive. Turn left onto Hayes Drive. Note: if you have gone past the blue Brilliant Electric Sign Co sign, you've gone too far. 210 Hayes Dr is the 2<sup>nd</sup> building on your left.

From the East via the Ohio Turnpike, get off at the I-77 exit. Follow the signs to I-77. Take I-77 North to I-480 West, immediately get off at the Rt 176 North/Brookpark exit. Stay on Rt 176 N and then follow above directions for >from Rt 176 North=

From the South (and hotels), take I-77 North to I-480 West, immediately get off at the Rt 176 North / Brookpark exit. Stay on Rt 176 N and follow above directions for >from Rt 176 North=
